Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

Alliance was awarded \$157,168 for grant NC0147L4F021604 for a 1 year grant cycle. By the end of the grant cycle, our agency expended a total \$127,036 of the grant funding. The remaining balance is \$17,552. There were several factors which contributed to the remaining balance including a shift the number of tenants participating in the Dash Program. One tenant experienced a TBI (traumatic brain injury) along with some cognitive deficiencies which prevented him from living independently as a participant in the program. Also, there was a large family who exited the Dash Program without following program protocol. Therefore, there was a significant amount of funds allocated which were underutilized as a result. The Dash Program is diligently working with the Durham CoC and other agencies to identify other potential applicants who are chronically homeless and would benefit from permanent supportive housing.

To address Durham’s unmet need for permanent supportive housing for individuals and families, Alliance designed the DASH supportive housing program in 2010 to provide rental assistance and supportive services to assist the most vulnerable households with an adult family member with a behavioral health disorder move from homelessness to affordable permanent housing. DASH provides a minimum of 12 permanent supportive housing scattered site units throughout the community for chronically homeless individuals and families with a documented behavioral health disability. Participants who are selected have received a VI-SPDAT and have been placed on the community wide prioritization lists. Households at the top of the single and/or family list are housed as long as the eligible candidates meet the definition of literally homelessness and have a documented disability in accordance with HUD regulations. To impact positive change in participant’s lives, DASH supportive housing program has implemented key components of the housing first approach to help people become housed and connected to mainstream services as quickly as possible. The DASH program offers permanent housing with no programmatic preconditions such as demonstration of sobriety, completion of alcohol or drug treatment, a source of income at entry or agreeing to comply with a treatment regimen upon entry into the program. However, DASH makes use of a full range of comprehensive and coordinated treatment and services for people with severe mental illness and co-occurring substance use disorders which includes: care coordination, medication management, life skills training, tenancy & budgeting training, behavioral health counseling, transportation and vocational services which can be essential in helping a head of household with complex life challenges improve decision making skills, community connections and behavioral health engagement. Research has shown that access to these readily available services and housing gives individuals and families a better quality of life, self-efficacy and reduces public spending through fewer hospitalizations, incarcerations and emergency room visits. This program performance supports the research as it has consistently had over a 85% housing stability rate and 75% outpatient service engagement rate for participants. Through continuing to invest in DASH Supportive Housing Program, Durham can anticipate significant fiscal savings and a healthier community over time. It is our hope the provision of innovative collaboration and blending of resources, DASH will continue to provide a more effective and cost efficient way to address the priorities of ending chronic homelessness and family homelessness by prioritizing household units who are identified as most in need for placement into available permanent housing through the VI-SPDAT

and care review process to help them afford a future of greater stability, better health and renewed hope.
