1. Provide a description that addresses the entire scope of the proposed project.

Andover Apartments provides Permanent Supportive Housing for single homeless persons with disabling conditions. Project staff utilizes the VI-SPDAT assessment tool to identify the best type of support and housing intervention for an individual. Additionally, the local Managed Care Organization (MCO) coordinates the Coordinated Entry process and its system of care providers refer potential tenants and provides services to tenants.

In total, there are 20 fully furnished efficiency units. 10 units are connected to the Target Key Waiver program, which is a state program for those unable to pay rent while they pursue their disability income. For the other units, rents are as low as \$190 per month or 30% of disability level income.

Housing for New Hope provides an opportunity for residents to work towards achieving self-sufficiency and independence. Residents can attend workshops that are offered to assist us in this endeavor. Workshops include: computer literacy training (finding and using resources on the internet), creating financial goals (budgeting and saving), encouraging continuing education, learning about healthy behaviors (prescription drug misuse and substance/alcohol abuse), learning effective communication skills (assertive versus aggressive communication), and linking residents to community partners that provide job development/training and placement.

Lastly, residents also have access to events such as Lunch and Learns with community volunteers, which Housing for New Hope organizes to build a sense of community.

3C. Dedicated Plus

Dedicated and DedicatedPLUS

A “100% Dedicated” project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

A “DedicatedPLUS” project is a permanent supportive housing project where 100% of the beds are dedicated to serve individuals with disabilities and families in which one adult or child has a disability, including unaccompanied homeless youth, that at a minimum, meet ONE of the following criteria according to NOFA Section III.3.d:


