3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Housing for New Hope Rapid Rehousing I project addresses the needs of homeless individuals and families, including veteran families, through the provision of rental assistance and case management. It is the goal of the RRH program to provide landlord outreach, housing location services, and intensive case management services to families with the proposed funds. Families are referred to our RRH program from local homeless shelters and other local non-profit service providers paying hotel/motel fees for homeless families. Additionally, our RRH program assists families that are living in a place not meant for human habitation.

Participating families and individuals will receive case management and training with budgets and overall independent living skills. The RRH Housing Coordinator and Housing Locator maintain positive and close relationships with local landlords, allowing our program to get the first opportunity to view properties as soon as they become available. In order to re-house program participants as quickly as possible, RRH staff work with clients to address potential poor rental or credit history and advocate on their behalf to local landlords. Also, Housing for New Hope maintains an active and engaged volunteer base, who frequently assist with moves, thus limiting potential constraints of the physical move itself.

Participants are also eligible to receive rental assistance, the provision of which is based on identified barriers. This project requests funding for the cost of three units, but turnover as well as the Rapid Rehousing team's ability to find and take advantage of units which rent for lower than Fair Market Rent, will likely result in approximately 6 family households being served throughout the year.

The Rapid Rehousing I program will work closely with agencies in Durham, such as Urban Ministries of Durham, Families Moving Forward, and the Department of Social Services, to properly intake homeless persons and families and connect them with housing and other services.


