3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Durham's Homeless Services Advisory committee has made ending family and youth homelessness a priority; the Housing for New Hope Rapid Rehousing III Program (RRH III) will address the needs of homeless families through the provision of rental assistance as well as case management. The Rapid Rehousing III program will also collaborate with Durham's veteran's service agencies to serve veteran families, if necessary, especially if they happen to be ineligible for VA services.

Participants of the RRH III program will receive case management in the areas of budgeting and overall independent living skills. They will also be provided with rental assistance, the provision of which will be based on barriers identified by the results of the Family SPDAT (Service Prioritization Decision Assistance Tool).

It is the goal of the RRH III program to move families into housing as quickly as possible by providing landlord outreach, housing location services, and intensive case management to families with the proposed funds. These families will be referred by local homeless shelters and other local non-profit service providers paying hotel/motel fees for homeless families. Additionally, our RRH III program assists families that are living in a place not meant for human habitation.

The RRH III program will work closely with other agencies in the Durham community on providing services to serve the homeless populations through the Continuum of Care Coordinated Intake process and connecting them with services after they are housed to improve their quality of life. These agencies include Urban Ministries of Durham, Families Moving Forward, the Department of Social Services, Wheels 4 Hope, and many others.

With turnover and the Rapid Rehousing team's ability to find quality units that rent for less than Fair Market Rent, we would anticipate that possibly 9 family households might be served by the program throughout the operating year, depending on funding, housing availability, and household barriers.

Based on information you supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).

If you establish that you have been a publicly supported organization, we will classify you as a section 509(a)(1) or 509(a)(2) organization as long as you continue to meet the requirements of the applicable support test. Also, if we classify you as a private foundation, we will treat you as a private foundation from your beginning date for purposes of section 507(d) and 4940.


