3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Streets to Home II is a scattered site permanent housing project for chronically homeless individuals. Program staff identifies eligible clients through the Coordinated Entry process and then connects with local landlords to secure affordable and appropriate housing for the population. Program staff consistently work to maintain relationships with these local landlords to encourage their continued participation.

To increase the chances of a successful transition, the program staff coordinate and oversee move-ins to enable chronically homeless households to access permanent housing through apartment leases. Housing for New Hope’s network of volunteer groups assist with the moves, as needed. Clients also receive "Ready-to-rent" classes, assistance obtaining benefits, healthcare navigation, and connection with various community resources. Additionally, eligible tenants are assisted with applications for emergency financial and utility assistance through Social Services and the local managed care organization should they need it, so that they are able to maintain their housing when faced with a housing crisis.

Housing for New Hope provides an opportunity for residents to work towards achieving self-sufficiency and independence. Residents can attend workshops that are offered to assist us in this endeavor. Workshops include: computer literacy training (finding and using resources on the internet), creating financial goals (budgeting and saving), encouraging continuing education, learning about healthy behaviors (prescription drug misuse and substance/alcohol abuse), learning effective communication skills (assertive versus aggressive communication), and linking residents to community partners that provide job development/training and placement.

Streets to Home II requests funding for the cost of 10 total one bedroom units. Streets to Home II may serve 10 participants at capacity, though community need and funding availability may allow for additional participants.



If your organization conducts fund-raising events such as benefit dinners, auctions, membership drives, etc., where something of value is received in return for contributions, you can help your donors avoid difficulties with their income tax returns by assisting them in determining the proper tax treatment of their contributions. To do this you should, in advance of the event, determine the fair market value of the benefit received and state it in your fund-raising materials such as solicitations, tickets, and receipts in such a way that your donors can determine how much is deductible and how much is not. To assist you in this, the Service has issued Publication 1391, *Deductibility of Payments Made to Charities Conducting Fund-Raising Events*. You may obtain copies of Publication 1391 from your local IRS Office. Guidelines for deductible amounts are also set forth in Revenue Ruling 67-246, 1967-2 C.B. 104 and Revenue Procedure 90-12, 1990-1 C.B. 471 and Revenue Procedure 92-49, 1992-26 I.R.B. 18.
