3B. Project Description

Housing for New Hope’s Andover Apartments is a Permanent Supportive Housing (PSH) community that is available to individuals experiencing chronic homelessness as identified on the Durham CoC's Chronic Homeless Prioritization List (By-Name List). Andover offers fully-furnished single-room efficiency units and all utilities are included. There is no designated length of stay, and residents may live in their units as long as they continue to meet the basic obligations of the lease agreement and eligibility requirements for PSH. Project staff aim to support residents' efforts to live independently and connect them to available community resources and services that promote safe and stable living. While participation in voluntary supportive services is encouraged, it is not a condition of tenancy.

Andover Apartments is a Housing First community, meaning residency does not require preconditions such as employment, income, absence of criminal record, or sobriety. Residents are not expected to have addressed behavioral health or substance abuse problems, or to graduate through a series of services programs before they can access housing. When residents choose to participate in supportive services, those services are available to them for the duration of their residency.

Housing for New Hope provides opportunities for residents to work towards achieving self-sufficiency and independence. Residents can attend workshops that are offered throughout the year. Workshops include: computer literacy training (finding and using resources on the internet), creating financial goals (budgeting and saving), encouraging continuing education, learning about healthy behaviors (prescription drug misuse and substance/alcohol abuse), learning effective communication skills (assertive versus aggressive communication), and linking residents to community partners that provide job development/training and placement.

Lastly, residents also have access to events such as Lunch and Learns with community volunteers, which Housing for New Hope organizes to build a sense of community.



HOUSING FOR NEW HOPE INC

You are required to make your annual return available for public inspection for three years after the return is due.* You are also required to make available a copy of your exemption application, and supporting documents, and this exemption letter. Failure to make these documents available for public inspection may subject you to a penalty of \$10 per day for each day there is failure to comply (up to a maximum of \$5,000 in the case of an annual return). See Internal Revenue Service Notice 88-120, 1988-2 C.B. 454, for additional information.

If your organization conducts fund-raising events such as benefit dinners, auctions, membership drives, etc., where something of value is received in return for contributions, you can help your donors avoid difficulties with their income tax returns by assisting them in determining the proper tax treatment of their contributions.
