2B. Project Description

1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with 24 CFR 578.7:

The City of Durham Community Development Department (CDD) serves as the Lead Agency for the Durham City and County Continuum of Care (NC-502). The Durham CoC is comprised of stakeholders from all sectors of Durham including: the continuum of homeless housing and service providers, North Carolina Central University, Duke University, representatives from local congregations, City of Durham Workforce Development, elected official from the City and County of Durham, the Durham VA Medical Center, Durham Department of Social Services, Durham Public Schools, the Durham county Sheriff, and leadership from other sectors of the community. The CDD's CoC planning responsibilities include, but are not limited to: provision of staff support for the CoC Board's committees, organizing the ESG and CoC grant application and selection process and submission off the collaborative applications, planning and carrying out the annual homeless Point in Time count as well as the Housing Inventory Count, coordination and submission of HUD required annual reports, provision of staff support for achieving objectives in the Collaborative Application, development and maintenance of the Durham CoC's website, updating written standards and review of governance documents, provision of technical assistance to homeless housing and service providers, implementation of the HMIS in coordination with the HMIS Lead Agency, and implementation of community wide strategic planning efforts of the Federal Plan to Prevent and End Homelessness. CoC Planning grant funds will be used to improve CDD's capacity to ensure the Durham CoC remains in compliance with 24 CFR 578.7. Planning funds will be used to pay for staff time to help the CoC meet goals outlined by HUD. Planning Grant funds will be used to assist with ensuring written standards are followed and updated if/when needed, evaluation of projects and the system as a whole, and ensuring coordination between service providers.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

The Planning Grant funds will be used starting at the beginning of the City of Durham’s fiscal year, July 1 and continue until the end of the fiscal year June 30. CoC meetings and subcommittee meetings occur monthly, agendas and minutes are kept for these meetings and posted on the City of Durham’s CoC website. The Performance Management Committee (subcommittee of the CoC’s governing board) with the help of the Community Development Department’s (CDD) staff monitor and evaluate CoC funded projects twice per year and Emergency Shelter Grant (ESG) programs at least annually. The purpose of these evaluations is to determine outcomes of the projects and identify low performing projects that need to improve performance or to have their funds reallocated. The Policy and Planning Committee (subcommittee of the CoC’s governing board) conducts a gaps analysis and coordinated entry assessment annually. CDD staff also provide support to a Lived Experience Work Group (started by the Policy and Planning Committee) provides input and guidance on solutions and policies that will improve the Homeless System in Durham. The work of CDD staff is coordinated by CDD’s Manager of the Homeless System with guidance and input from the governing body of the CoC. All tasks are completed on time to ensure compliance with HUD timelines/deadlines and/or internal monitoring timelines.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

The CoC planning grant will allow the Community Development Department (CDD) staff to allocate more time to evaluation of ESG projects in addition to the CoC NOFO funded projects.
