1. Describe your organization’s (and subrecipient(s) if applicable) experience in effectively utilizing federal funds and performing the activities proposed in the application.

The LGBTQ Center of Durham has a successful history of effective work concerning housing services and services to survivors of sexual assault, domestic violence, dating violence, and stalking.

The organization's mission statement: "The LGBTQ Center of Durham supports LGBTQ+ people through services, programming, resources, and support networks that center their wellbeing and allows them to thrive."

Our demonstrated history of providing services and utilizing federal funds is as follows:

We began providing a resource director for our clients to help them be connected with the services needed to overcome a history of survivorship in 2016. (5 years)

In 2019, we created a housing program (initially the Host Home Program), funded by SAMHSA block grant funds through the NC Division of Mental Health, Developmental Disabilities, and Substance Abuse (DMHDDSA), to provide LGBTQ+ transition aged youth (18-24) with housing, including those who are survivors of violence, through the host home model, short term hotel stays, and transitional/rapid rehousing. Additionally, have provided direct mental health services with contractors and case management. Survivors receiving housing and mental health services have been funded by Governor’s Crime Commission (GCC) funds through the Office on Violence Against Women (OVW) and the Violence Against Women Act (VAWA) funding at the federal level. (2.5 years)

In 2020, we transitioned our host home program to a rapid rehousing/transitional housing program and continued providing direct services to LGBTQ+ folks and LGBTQ folks who are survivors of violence through an additional grant from GCC through Victims of Crime Act (VOCA) funding at the federal level. In early 2021, we hired our first Victim Advocate position to support and supplement the case management work already being done by our housing case manager. (1 year)

Through our housing and therapy work, we have, since early 2019, been able to serve 24 housing clients, all of whom have been LGBTQ+ people, and 21 case management and therapy only clients, also all of whom have been LGBTQ+ people. Of note, all housing clients also received therapy services, meaning we have served 45 therapy clients total. Additionally, these 45 individuals are majority Transgender and Black, Brown, Indigenous, and People of Color (BIPOC). Through the shift to providing rapid rehousing/tenant based rental assistance from host homes, our successful exits from our housing program

have gone from 0% in year one to 60% in our most recent fiscal year and 75% in our current fiscal year.

The LGBTQ Center of Durham is the primary applicant for this project and seeks to continue providing robust rapid rehousing and supportive services to new, adult, LGBTQ+ survivors of violence in Durham, NC.

2. Describe your organization’s (and subrecipient(s) if applicable) experience in leveraging Federal, State, local and private sector funds.

The Center maintains a strategy with sustainability at the forefront of our minds. Specifically, we always keep a reserve on expenditures ensuring we can handle a major financial setback. The private foundations we are currently working to partner with are expected to fund us at around \$200,000 per year. Securing this [CoC] project grant would activate interest in providing further funding to sustain the rapid rehousing program beyond this funding cycle. Additionally, we have been working to build our monthly donor base and saw a significant increase in monthly giving in 2020 after we implemented the use of our first Constituent Resource Management (CRM) database, which increased our annual giving by 100%. Finally, we are moving to a larger, more robust space in 2022, making space for a capital campaign to set us up for further financial success.

The LGBTQ Center of Durham uses QuickBooks, the assistance of a CPA, and codes all of our spending to confirm that we are on track with each of our grants. Our financial policies require three confirmations of spending each month including the Finance Chair from the Board of Directors, the Executive Director, and our CPA. The Center has also recently hired a Deputy Director who will support the financial management structure of the agency and expand the capabilities of the Center to effectively manage ever-growing funding streams, donors, and grants, both private and government-based.

1. Provide a description that addresses the entire scope of the proposed project.

Our Center has always led with response to the most immediate needs of our LGBTQ+ community, which means we prioritize the needs of Queer, Transgender, Black, Indigenous, and People of Color (QTBIPOC) individuals across all of our services, especially our housing and mental health services. Since the onset of the Covid 19 pandemic, we have seen a sharp increase, almost on a daily basis, of inquiries for housing and mental health support. Our agency’s social services arm, Project FAM, is committed to supporting and being directly involved in the CoC’s efforts to reduce and prevent homelessness in and around Durham City and County, especially since we have already been doing this work. We have learned that our housing work in particular fills critical service gaps that currently exist in the CoC and broader housing systems in Durham. This project will allow us to continue expanding our response to these service gaps and afford us resources to meet the needs of our LGBTQ+ community who are also overly burdened by the impact of Covid-19. Therefore, we are seeking this project funding in order to grow our existing rapid rehousing project services with a focus on these services towards survivors of violence.

This project will focus on:

- Housing Relocation and Stabilization Services
- Rental Application Fees
- Security Deposits
- Last Month’s Rent
- Utility Deposits (including Internet)
- Utility Payments (including Internet)
- Utility Arrears (up to 6 months per service)
- Moving Costs
- Housing Search and Placement
- Housing Stability Case Management
- Direct, low barrier, contracted mental health services with 5 contracted clinicians already under contract with the Center

The Senior Housing Case Manager at the Center will serve as a direct point of contact and support for project clients. This person will provide ongoing support in order to facilitate the achievement of housing stability for participants who have obtained and maintained permanent housing through the rapid rehousing project. Case Management will include:

- Developing, in conjunction with the participant, an individualized housing and service plan with a path to permanent housing stability.
- Developing, securing, and coordinating services.
- Obtaining federal, state, and local benefits.
- Monitoring and evaluating project participants' progress towards goals.
- Providing information about and referrals to other providers.
- Conducting evaluations at least every three months to determine ongoing project eligibility.

2. Describe the specific plan to coordinate and integrate with other mainstream health, social services, and employment programs for which program participants may be eligible.

Resource navigation is a universal issue at our agency - each staff member is responsible for some aspect of resource navigation. That being said, our senior case manager will be the primary staff member responsible for providing resource navigation support for this project unless the client seeks deeper gender affirmation services. Our Gender Resources Advocacy and Support Program (GRASP) program under Project FAM is specifically in place to provide in depth, hands-on support needed for gaining access to gender affirming employment, medical, and legal resources. Under this project, clients who continue with us through the full suite of services offered at our agency are likely to access job placement and training resources which are through our local partners, NCWorks and NC NextGen. Our ongoing relationships built through the host home program in accessing these resources has been exceptionally beneficial. Our case manager maintains these relationships and connects the clients appropriately based on their goals for their future. Additionally, clients will be made aware of all additional resources and programs available to them on a case by case basis, including access to Food Stamps (SNAP), WIC, Disability applications, other employment services, vital documents services, and financial planning services, to name a few.
