UMD’s CoC Fresh Start program which we are now seeking to expand, launched in 2017 and helps chronically homeless clients with a disability obtain and maintain housing with a combination of housing-focused case management and temporary financial assistance. The program is led by Tanya Sutton, who has 15+ years of clinical experience, including four years as Executive Director of a transitional housing organization. Since 2020, UMD has also utilized federal funding passed down through state and local governments to assist with Covid-19 related needs.

2. Describe your organization’s (and subrecipient(s) if applicable) experience in leveraging Federal, State, local and private sector funds.

Leveraging funding is a crucial activity shared by UMD’s Administration and Fundraising departments. Pre-Covid, UMD has consistently balanced diverse sources of funding, with governmental grants, foundation support, and individual giving each providing roughly one-quarter of our budget. This past fiscal year these percentages are distorted by additional government support for operating a temporary non-congregate shelter location due to the pandemic (ex. government 40% individual donors, 26%, foundations 22%, businesses 6%, congregations and community/civic groups 5%, special events 2% etc.). Despite these shifts, UMD has seen increased funding last fiscal year since 2019-2020: individuals 4%, congregations 22%, businesses 31%, foundations 99%).

Our organization receives careful oversight from our Finance Director, the Board, and its Finance and Executive Committees and maintains separation of duties and effective internal controls. Financial statements are prepared monthly by the Director of Finance who then provides them to the Board Treasurer for review. The Treasurer chairs the Finance committee made up of a mix of Board and community members. The Committee meets every other month where statements are reviewed again. The Treasure also sits on the Executive Committee and gives regular reports, in addition to sporadic reports to the Board of Directors.

1. Provide a description that addresses the entire scope of the proposed project.

Urban Ministries of Durham (UMD) seeks to expand Fresh Start Durham, a progressive engagement rapid rehousing (RRH) initiative to enhance Durham’s system for serving chronically homeless single adults. Chronically homeless single adults who are not eligible for veteran’s services, have been in the shelter for over 60 days with no prospects for housing, have demonstrated the potential for at least part-time earned income to end their homelessness will be considered for rapid rehousing prior to permanent supportive housing. Via this progressive engagement approach, limited permanent supportive housing will not be used for those who can sustain housing via a less intensive option, more chronically homeless persons will be housed and lengths of stay in shelter will be reduced. The goal is to expand services to house 6 additional individuals. Fresh Start Durham (CoC) will also add one new case manager to work with all program participants to implement a personalized Pathway Plan, to gain and sustain income, housing, mainstream benefits and achieve other identified goals. Using a Housing First approach, the additional case manager will ensure that participants receive rental financial assistance, generally for up to 6 months, combined with life skills, financial management training, employment support, medical referrals and connections with providers and mainline benefits. The additional case manager will increase capacity for greater landlord engagement and participant aftercare. UMD will partner with Durham Literacy Council, Community Empowerment Fund, Durham Tech, StepUp Durham, Lincoln Community Health, Alliance Behavioral Healthcare, and homeless service providers, to enhance workforce and housing stability. Though clients may live wherever their budgets allow, shared housing will be encouraged as permanent rental options to provide a financially feasible fresh start and a path to long term self-sufficiency. If after 6 months there are individuals who are demonstrating that they are not able to maintain permanent housing with rapid rehousing and need more extensive intervention, they will be prioritized for Housing Choice Vouchers provided for homeless persons by Durham Housing Authority and permanent supportive housing offered by CoC providers through the community’s system for housing chronically homeless persons. UMD piloted an approach similar to Fresh Start in Spring 2015 for nine selected adult participants. We subsequently entered the CoC FY2015 grant funding competition and received notice of awarded funding in May 2016 to support Fresh Start Durham. We began service in March 2017 and so far, have housed 76 chronically homeless clients. Our expansion project would increase funding to serve additional clients, and increase our full-time staff from one case manager to two case managers.

Using the best practices of housing-first and low-barrier philosophies, UMD seeks to reduce barriers that prevent homeless neighbors from taking advantage of an emergency shelter stay while focusing their stay on obtaining housing as quickly and responsibly as possible. We offer client-centered case management by trained case managers who collaborate with the client to address the three domains of housing, wellness, and income. Each person makes a customized Housing Plan, a series of goals to accomplish to leave shelter for their own apartment. Case Managers assist participants with the goal of obtaining permanent housing within 30 days. CoC Fresh Start startup assistance can include a security deposit, 1st month's rent, previous evictions and utility deposits). Financial assistance is time-limited, and households are expected to contribute an appropriate amount to their housing costs at some point, yet client income is not required for eligibility. Clients are provided assistance with aftercare support from their case manager for at least one year.

2. Describe the specific plan to coordinate and integrate with other mainstream health, social services, and employment programs for which program participants may be eligible.

Case managers offer coordinated referrals to partner service providers in the community, who help with goals such as finding a job, improving literacy, resolving legal issues, getting health and mental health care, and others. These referrals include our in-house Workforce Development program, Community Cafe, and Food Pantry and Clothing Closet.
