Our Center has always led with response to the most immediate needs of our LGBTQ+ community, which means we prioritize the needs of Queer, Transgender, Black, Indigenous, and People of Color (QTBIPOC) individuals across all of our services, especially our housing and mental health services. Since the onset of the Covid 19 pandemic, we have seen a sharp increase, almost on a daily basis, of inquiries for housing and mental health support. Our agency's social services arm, Project FAM, is committed to supporting and being directly involved in the CoC's efforts to reduce and prevent homelessness in and around Durham City and County, especially since we have already been doing this work. We have learned that our housing work in particular fills critical service gaps that currently exist in the CoC and broader housing systems in Durham. This project will allow us to continue expanding our response to these service gaps and afford us resources to meet the needs of our LGBTQ+ community who are also overly burdened by the impact of Covid-19. Therefore, we are seeking this project funding in order to grow our existing rapid rehousing project services with a focus on these services towards survivors of violence.

This project will focus on:

- Housing Relocation and Stabilization Services
 - Rental Application Fees
 - Security Deposits
 - Last Month's Rent
 - Utility Deposits (including Internet)
