3B. Project Description

Housing for New Hope’s Rapid Rehousing I (RRH 1) project helps individuals and families exit homelessness as quickly as possible, return to permanent housing, and achieve long-term stability. The RRH 1 program provides an immediate permanent housing solution for vulnerable homeless individuals and families by providing short- and/or medium-term rental assistance and services. RRH 1 focuses on eliminating tenancy barriers for program participants, provides housing location services, and supports households by providing financial assistance for housing related expenses. Utilizing a progressive-engagement approach, the RRH 1 program tailors financial assistance and housing stabilization services to meet the specific needs of each household and promote their long-term stability in housing.

The RRH 1 program participates in the Durham CoC’s Coordinated Entry processes and accepts referrals from the By-Name List. Upon program eligibility verification and acceptance of the referral, RRH 1 staff begin working with participants to assess their housing stabilization needs, address potential poor rental or credit history, and advocate on their behalf to local landlords. The Program Manager and the Housing Locator maintain close, positive relationships with a network of local landlords, which allows our program to get the first opportunity to have access to properties as soon as they become available. In addition to housing location services, program participants also receive case management, rental payment assistance, connections to mainstream services, and assistance with developing overall independent living skills. Additionally, Housing for New Hope maintains an active and engaged volunteer base who frequently assist with moves, thus limiting potential constraints of the physical move itself.

This project requests funding for the cost of three units, but turnover as well as the RRH 1 staff’s ability to find and take advantage of units which rent for lower than Fair Market Rent, will likely result in approximately 6 households being served throughout the year. 

You are required to make your annual return available for public inspection for three years after the return is due.* You are also required to make available a copy of your exemption application, and supporting documents, and this exemption letter. Failure to make these documents available for public inspection may subject you to a penalty of \$10 per day for each day there is failure to comply (up to a maximum of \$5,000 in the case of an annual return). See Internal Revenue Service Notice 88-120, 1988-2 C.B. 454, for additional information.

If your organization conducts fund-raising events such as benefit dinners, auctions, membership drives, etc., where something of value is received in return for contributions, you can help your donors avoid difficulties with their income tax returns by assisting them in determining the proper tax treatment of their contributions. To do this you should, in advance of the event, determine the fair market value of the benefit received and state it in your fund-raising materials such as solicitations, tickets, and receipts in such a way that your donors can determine how much is deductible and how much is not. To assist you in this, the Service has issued Publication 1391, *Deductibility of Payments Made to Charities Conducting Fund-Raising Events*. You may obtain copies of Publication 1391 from your local IRS Office. Guidelines for deductible amounts are also set forth in Revenue Ruling 67-246, 1967-2 C.B. 104 and Revenue Procedure 90-12, 1990-1 C.B. 471 and Revenue Procedure 92-49, 1992-26 I.R.B. 18.
