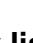

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Housing for New Hope's Rapid Rehousing III (RRH 3) project addresses the needs of individuals and families experiencing homelessness through the provision of housing location services, intensive case management, and time-limited rental assistance. The goal of the RRH 3 program is to help individuals and families exit homelessness as quickly as possible, return to permanent housing, and achieve long-term stability. The RRH 3 program will also collaborate with Durham's veteran's service agencies to serve veteran families, if necessary, especially if they happen to be ineligible for VA services. RRH 3 focuses on eliminating tenancy barriers for program participants by advocating on their behalf with landlords and supports households by providing financial assistance for housing related expenses. Utilizing a progressive-engagement approach, the RRH 3 program will use the proposed funds to tailor financial assistance and housing stabilization services to meet the specific needs of each household and promote their long-term stability in housing.

Participating in the Durham CoC's Coordinated Entry processes which prioritize vulnerable households for assistance, the RRH 3 program accepts referrals for households identified on the By-Name List. As soon as a household is enrolled into the program, staff begin working with program participants to assess their housing stabilization needs, address potential poor rental or credit history, and advocate on their behalf to local landlords. The Program Manager and the Housing Locator maintain close, positive relationships with a network of local landlords, which allows our program to get the first opportunity to access affordable properties as soon as they become available. In addition to housing location services, case management, and financial assistance, program participants also receive connections to mainstream services and assistance with developing overall independent living skills.

The RRH 3 program will work closely with other Durham community agencies that provide services for people experiencing homelessness which may help program participants improve their quality of life and can aid households achieve long-term stability in their chosen housing. 

HOUSING FOR NEW HOPE INC

You are required to make your annual return available for public inspection for three years after the return is due.* You are also required to make available a copy of your exemption application, and supporting documents, and this exemption letter. Failure to make these documents available for public inspection may subject you to a penalty of \$10 per day for each day there is failure to comply (up to a maximum of \$5,000 in the case of an annual return). See Internal Revenue Service Notice 88-120, 1988-2 C.B. 454, for additional information.

If your organization conducts fund-raising events such as benefit dinners, auctions, membership drives, etc., where something of value is received in return for contributions, you can help your donors avoid difficulties with their income tax returns by assisting them in determining the proper tax treatment of their contributions. To do this you should, in advance of the event, determine the fair market value of the benefit received and state it in your fund-raising materials such as solicitations, tickets, and receipts in such a way that your donors can determine how much is deductible and how much is not. To assist you in this, the Service has issued Publication 1391, *Deductibility of Payments Made to Charities Conducting Fund-Raising Events*. You may obtain copies of Publication 1391 from your local IRS Office. Guidelines for deductible amounts are also set forth in Revenue Ruling 67-246, 1967-2 C.B. 104 and Revenue Procedure 90-12, 1990-1 C.B. 471 and Revenue Procedure 92-49, 1992-26 I.R.B. 18.
