The Streets to Home Program (STH) experienced a \$9,134 shortfall during the 9/01/2021 - 8/31/2022 operating year. The operational underrun is due to the Rental Assistance line item not being fully expended. STH has been very successful with identifying affordable units for program participants that rent for less than the HUD Fair Market Rent amount for the Durham/Chapel Hill Metro area. On average, the monthly rental amount for program participants is \$786; however, the FMR for this area is \$1030. Coupled with the fact that a third of the STH caseload has income and contributes 30% of their income towards their monthly rent, it creates a situation where the program is consistently underspending by about \$240/participant each month of the operating year. Overall, this means that the STH program spent less on Rental Assistance than we initially anticipated when we applied for funding. Our program is navigating the balance between enrolling more households and STH staff ability to provide quality case management services to program participants. Another reason for the underrun is that the program was unable to fill the vacancies created by participants that exited the program. While STH had 3 leavers, there were only 2 participants added to the caseload during the above mentioned operating year.

Housing for New Hope’s (HNH) Streets to Home I Program (STH) is a scattered-site permanent supportive housing (PSH) project that links affordable, community-based housing with flexible and voluntary support services to individuals and families experiencing homelessness as identified on the Durham CoC's Homeless Prioritization By-Name-List. The project has no designated length of stay, and participants may live in their chosen units as long as they continue to meet the basic obligations of the lease agreement and eligibility requirements for PSH. STH's goal is to help participants choose local affordable housing options, support their efforts to live independently, and connect them to available community resources and services that promote safe and stable living.

STH staff maintain positive relationships with local property management companies and private landlords in order to encourage their continued participation in the project. The strength of these relationships allows participants to secure and lease safe, affordable permanent housing in the greater Durham area. Once participants identify housing, STH staff coordinate and oversee move-ins to assist the household settle into their new home.

While enrolled in STH, participants receive an array of services including monthly rental assistance, connections to and assistance with obtaining mainstream benefits, healthcare navigation, and connections to various community resources. STH assists eligible program participants with applications for emergency financial and utility assistance through the Durham Department of Social Services should they need it, so that they are able to maintain their housing when faced with a housing crisis.

HNH provides opportunities for STH participants to work towards achieving self-sufficiency and independence, and ultimately achieve a successful Move On from the program. Move On plans are actualized with Housing Choice Vouchers from the Durham Housing Authority or by helping participants build/rebuild natural supports which can lead to them graduating from support services. Staff encourage participants to attend workshops that are offered to increase their life-skills. These workshops include: computer literacy training, budgeting and saving, learning about healthy behaviors and effective communication skills, and linking residents to community partners that provide job development, training, and placement.

Based on information you supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).

Because you are a newly created organization, we are not now making a final determination of your foundation status under section 509(a) of the Code. However, we have determined that you can reasonably expect to be a publicly supported organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

Accordingly, during an advance ruling period you will be treated as a publicly supported organization, and not as a private foundation. This advance ruling period begins and ends on the dates shown above.

Within 90 days after the end of your advance ruling period, you must send us the information needed to determine whether you have met the requirements of the applicable support test during the advance ruling period. If you establish that you have been a publicly supported organization, we will classify you as a section 509(a)(1) or 509(a)(2) organization as long as you continue to meet the requirements of the applicable support test. If you do not meet the public support requirements during the advance ruling period, we will classify you as a private foundation for future periods. Also, if we classify you as a private foundation, we will treat you as a private foundation from your beginning date for purposes of section 507(d) and 4940.

Grantors and contributors may rely on our determination that you are not a private foundation until 90 days after the end of your advance ruling period. If you send us the required information within the 90 days, grantors and contributors may continue to rely on the advance determination until we make a final determination of your foundation status.

If we publish a notice in the Internal Revenue Bulletin stating that we



You are required to make your annual return available for public inspection for three years after the return is due.* You are also required to make available a copy of your exemption application, and supporting documents, and this exemption letter.
