The Streets to Home II project (STH 2) experienced a \$34,813 shortfall during the 2/01/2022 - 1/31/2023 operating year. The operational underrun is due to the Rental Assistance line item not being fully expended. STH 2 has been very successful with identifying affordable units for program participants that rent for less than the HUD Fair Market Rent amount for the Durham/Chapel Hill Metro area. On average, the monthly rental amount for program participants is \$886; however, the FMR for this area is \$1030. Coupled with the fact that 54% of the STH 2 caseload has income and contributes 30% of their income towards their monthly rent, it creates a situation where the program is consistently underspending by about \$144/participant each month of the operating year. This difference alone accounts for over \$27,000 in unspent Rental Assistance. Overall, this means that the STH 2 program spent less on Rental Assistance than we initially anticipated when we applied for funding. Another reason for the underrun is that the program was unable to fill the vacancies created by participants that exited the program. While STH 2 had 8 leavers, there were no new participants added to the caseload. The population served in STH 2 have numerous barriers to housing, which make them a very difficult population to provide housing and essential services to. STH 2 is constantly navigating the balance between enrolling more households and staff's ability to provide quality case management services to program participants.

Housing for New Hope's Streets to Home II Program (STH) is a scattered-site permanent supportive housing (PSH) project that links affordable, community-based housing with flexible and voluntary support services to individuals and families experiencing chronic homelessness as identified on the Durham CoC's Homeless Prioritization By-Name-List. There is no designated length of stay, and program participants may live in their chosen units as long as they continue to meet the basic obligations of the lease agreement and eligibility requirements for PSH. The goal of the program is to help participants choose local affordable housing options, support their efforts to live independently, and connect them to available community resources and services that promote safe and stable living.

STH staff maintain positive relationships with local property management companies and private landlords in order to encourage their continued participation in this PSH project. The strength of these relationships allows program participants to secure and lease safe, affordable permanent housing in Durham and surrounding areas. When program participants have identified their housing, STH staff coordinate and oversee move-ins to assist the household settle into their new home.

While enrolled in the STH program, participants receive an array of services including monthly rental assistance, connections to and assistance with obtaining mainstream benefits, healthcare navigation, and connections to various community resources. Additionally, eligible program participants are assisted with applications for emergency financial and utility assistance through the Durham Department of Social Services should they need it, so that they are able to maintain their housing when faced with a housing crisis.

Housing for New Hope provides opportunities for STH program participants to work towards achieving self-sufficiency and independence, and ultimately achieving a successful Move On from the program. Move On plans are often actualized with Housing Choice Vouchers from the Durham Housing Authority or by helping program participants build or rebuild natural supports which can lead to them moving in with family or friends. Participants are encouraged to attend workshops that are offered to increase their life-skills. These workshops include: computer literacy training (finding and using resources on the internet), creating financial goals (budgeting and saving), encouraging continuing education, learning about healthy behaviors (prescription drug misuse and substance/alcohol abuse), learning effective communication skills (assertive versus aggressive communication), and linking residents to community partners that provide job development, training, and placement.
