### 3B. Project Description

Housing for New Hope’s Rapid Rehousing III (RRH 3) project addresses the needs of individuals and families experiencing homelessness through the provision of housing location services, intensive case management, and time-limited rental assistance. The goal of the RRH 3 program is to help individuals and families exit homelessness as quickly as possible, return to permanent housing, and achieve long-term stability. RRH 3 focuses on eliminating tenancy barriers for program participants by advocating on their behalf with landlords and supports households by providing financial assistance for housing related expenses. Utilizing a progressive-engagement approach, the RRH 3 program will use the proposed funds to tailor financial assistance and housing stabilization services to meet the specific needs of each household and promote their long-term stability in housing.

Participating in the Durham CoC’s Coordinated Entry processes which prioritize vulnerable households for assistance, the RRH 3 program accepts referrals for households identified on the By-Name-List. As soon as a household is enrolled into the program, staff begin working with program participants to assess their housing stabilization needs, address potential poor rental or credit history, and advocate on their behalf to local landlords. The Program Manager and the Housing Locator maintain close, positive relationships with a network of local landlords, which allows our program to get the first opportunity to access affordable properties as soon as they become available. In addition to housing location services, case management, and financial assistance, program participants also receive connections to mainstream services and assistance with developing overall independent living skills.

The RRH 3 program will work closely with other Durham community agencies that provide services for people experiencing homelessness which may help program participants improve their quality of life and can aid households achieve long-term stability in their chosen housing. These agencies include Urban Ministries of Durham, Families Moving Forward, the Durham Housing Authority, the Department of Social Services, Wheels 4 Hope, and many others.

This project requests funding for the cost of six units, but with caseload turnover and program staff’s ability to find quality units that rent for less than Fair Market Rent, we anticipate that as many as 9 family households might be served by the program throughout the operating year depending on funding, housing availability, and household barriers.

Dear Applicants:

Based on information you supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).

Because you are a newly created organization, we are not now making a final determination of your foundation status under section 509(a) of the Code. However, we have determined that you can reasonably expect to be a publicly supported organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

Accordingly, during an advance ruling period you will be treated as a publicly supported organization, and not as a private foundation. This advance ruling period begins and ends on the dates shown above.

Within 90 days after the end of your advance ruling period, you must send us the information needed to determine whether you have met the requirements of the applicable support test during the advance ruling period. If you establish that you have been a publicly supported organization, we will classify you as a section 509(a)(1) or 509(a)(2) organization as long as you continue to meet the requirements of the applicable support test. If you do not meet the public support requirements during the advance ruling period, we will classify you as a private foundation for future periods. Also, if we classify you as a private foundation, we will treat you as a private foundation from your beginning date for purposes of section 507(d) and 4940.

Grantors and contributors may rely on our determination that you are not a private foundation until 90 days after the end of your advance ruling period. If you send us the required information within the 90 days, grantors and contributors may continue to rely on the advance determination until we make a final determination of your foundation status.

If we publish a notice in the Internal Revenue Bulletin stating that we

will no longer treat you as a publicly supported organization, grantors and contributors may not rely on this determination after the date we publish the notice. In addition, if you lose your status as a publicly supported organization, and a grantor or contributor was responsible for, or was aware of, the act or failure to act, that resulted in your loss of such status, that person may not rely on this determination from the date of the act or failure to act. Also, if a grantor or contributor learned that we had given notice that you would be removed from classification as a publicly supported organization, then that person may not rely on this determination as of the date he or she acquired such knowledge.

If you change your sources of support, your purposes, character, or method of operation, please let us know so we can consider the effect of the change on your exempt status and foundation status. If you amend your organizational document or bylaws, please send us a copy of the amended document or bylaws. Also, let us know all changes in your name or address.

As of January 1, 1984, you are liable for social securities taxes under the Federal Insurance Contributions Act on amounts of \$100 or more you pay to each of your employees during a calendar year. You are not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the private foundation excise taxes under Chapter 42 of the Internal Revenue Code. However, you are not automatically exempt from other federal excise taxes. If you have any questions about excise, employment, or other federal taxes, please let us know.

Donors may deduct contributions to you as provided in section 170 of the Internal Revenue Code. Bequests, legacies, devises, transfers, or gifts to you or for your use are deductible for Federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.

Donors may deduct contributions to you only to the extent that their contributions are gifts, with no consideration received. Ticket purchases and similar payments in conjunction with fundraising events may not necessarily qualify as deductible contributions, depending on the circumstances. Revenue Ruling 67-246, published in Cumulative Bulletin 1967-2, on page 104, gives guidelines regarding when taxpayers may deduct payments for admission to, or other participation in, fundraising activities for charity.

You are not required to file Form 990, Return of Organization Exempt From Income Tax, if your gross receipts each year are normally \$25,000 or less. If you receive a Form 990 package in the mail, simply attach the label provided, check the box in the heading to indicate that your annual gross receipts are normally \$25,000 or less, and sign the return.

If you are required to file a return you must file it by the 15th day of the fifth month after the end of your annual accounting period. We charge a penalty of \$10 a day when a return is filed late, unless there is reasonable

cause for the delay. However, the maximum penalty we charge cannot exceed \$5,000 or 5 percent of your gross receipts for the year, whichever is less. We may also charge this penalty if a return is not complete. So, please be sure your return is complete before you file it.

You are not required to file federal income tax returns unless you are subject to the tax on unrelated business income under section 511 of the Code. If you are subject to this tax, you must file an income tax return on Form 990-T, Exempt Organization Business Income Tax Return. In this letter we are not determining whether any of your present or proposed activities are unrelated trade or business as defined in section 513 of the Code.


